Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations"), the Company has entered into a Share Purchase Agreement ("SPA") with unincorporated consortium led by Premier International Convention Centre & Hotel, a partnership firm, to sell and transfer the entire equity shareholding held by the Company in Karyavottam Sports Facilities Limited ("KSFL"), a wholly owned subsidiary of the Company ("the proposed Transaction"). As stated therein, the transaction is subject to receipt of various approvals including *inter alia* from National Company Law Tribunal and the Concessioning Authority.

The details of sale as required under Regulation 30 of the SEBI Listing Regulations read with SEBI circular No. CIR/CFD/CMD/4/2015 dated September 9, 2015 is attached herewith as **Annexure A**.
